Karen Glaser, Family Area Committee Member The five Focus Area Committees (FACs) are now working hard to find the five nonprofit finalists that will be announced before the awards dinner and voted on by our membership that evening. Approximately 90 women are serving on the committees.

Impact committee members have completed the initial winnowing step for the Letter of Inquiry phase of the grant process and have invited 23 nonprofits to submit full applications on March 20.

• Pecar Update



Read What's Happening at Pecar

Last year's grant recipient, and Impact's first award winner, Wishard's Pecar Center has begun the process of looking for staff to manage the Impact 100 Pharmacy. Construction should be completed by mid to late April and the pharmacy is scheduled to open mid June 2007, according to the final interim report prepared by the Wishard Memorial Foundation for the Impact Pharmacy.

Impact 100 Greater Indianapolis awarded \$152,000 to the Wishard Memorial Foundation for the Pecar Health Center at our awards dinner in June of 2006. Two installment payments have been made to the foundation, and the final payment is due April 1. Patients are anxious for the on-site pharmacy to open because it will immediately improve access to needed medication for the atrisk population served by the health center. The Pecar Health Center served 10,000 patients in 2005.
